What we collect

We may collect the following information:

- Name and address
- Contact information including email address, and phone numbers.
- Demographic information such as postcode
- Other information relevant to contacting customer

What we do with the information we gather

- All orders submitted online are processed through secure checkout systems provided by PAYPAL, and SQUARE UP and consequently you are guaranteed the best security available. Paypal or SQUARE UP will never provide us with your paypal or any linked bank account details.
- All orders made by phone are processed by SQUARE UP Secure Virtual Terminal.

Security

We are committed to ensuring that your information is secure. We protect your information using technical and administrative security measures to reduce the risks of loss, misuse, unauthorized access, disclosure and alteration. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

The transmission of information is encrypted and protected using Secure Sockets Layer (SSL) by Let's Encrypt CA provided by the [Internet Security Research Group \(ISRG\)](#). Stored customer information is kept in a secure environment where accessed only to perform a specific job (for example administration).

Web Stats

We use web traffic stats to identify which pages are being used. This contains date, time, browser and geographical statistics and not personal user data. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes.

These web stats help us provide you with a better website, by enabling us to monitor which pages users find useful and which you do not. These stats in no way gives us access to your computer or any information about you, other than the data you choose to share with us.
